Walk for Clean Air Planning Committee

Role: To engage Johnson County communities in annual tobacco control awareness event, the Walk for Clean Air

Sub-Committees: Sponsorship, Registration, Day of Event Activities, Logistics, Media/Promotion

Time Commitment: Monthly meetings in fall, twice a month in spring, weekly in April

Training Required: CAFE Volunteer Orientation (1 hr)

Advocacy Team (A-Team)

Role: To educate local, county and state elected officials about tobacco control policy initiatives

Activities: Email campaigns, letters to the editor, petition drives, attendance at legislative forums, etc.

Time Commitment: As available for activities; an occasional strategy session may be scheduled

Communication: Primarily email, some phone calls

Training Required: CAFE Volunteer Orientation (1 hr), Advocacy training (1 hr)

Impact Team

Role: To assist CAFE staff with organizational functions

Activities: Data entry, membership follow-up, database management, website maintenance, newsletter production

Time Commitment: Set your own schedule of office hours

Training Required: CAFE Volunteer Orientation (1 hr)

Community Ambassadors

Role: To raise awareness of CAFE and educate about tobacco control in the county

Activities: Host information tables/booths at community events, participate in parades, distribute flyers, etc.

Time Commitment: As available for activities; planning meeting may be held prior to large events

Communication: Primarily email, some phone calls

Training Required: CAFE Volunteer Orientation (1 hr)

Youth Council

Role: Provide ideas and direction for CAFE's youth prevention efforts, including Just Eliminate Lies (JEL)

Activities: Street marketing, Kick Butts Day, Tar Wars program, Great American Smokeout

Time Commitment: Six meetings per year, as available for activities

Communication: Primarily email, some phone calls

Training Required: CAFE Youth Orientation (1 hr) or CAFE Volunteer Orientation (1 hr)
